Sunday, January 1, 2023	<ul style="list-style-type: none"> • First day to apply for a ballot by mail (ABBM) or for a Federal Postcard Application (FPCA)
Wednesday, January 18, 2023	<ul style="list-style-type: none"> • First day candidates may file an application for place on the ballot in the General Election • First day for filing declaration of write-in candidacy • At this time, the Appointment of a Campaign Treasurer Form (CTA) may be submitted
Friday, February 17, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – Last day candidates may file an application for place on the ballot in the General Election • Appointment of a Campaign Treasurer Form (CTA) must also be received by <u>5:00 p.m.</u> • Last day to order General Election or Special Election on a Measure
Tuesday, February 21, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – Last day for a write-in candidate to declare candidacy in the General Election
Friday, February 24, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – Last day for a ballot or write-in candidate in the General Election to submit a certificate of withdrawal and have name omitted from the ballot • <u>5:00 p.m. deadline</u> – Last day that a declaration of ineligibility causes omission of candidate's name from ballot in the General Election
Monday, February 27, 2023	<ul style="list-style-type: none"> • 9:00 a.m. – Drawing for order of names on ballot at Killeen City Hall – City Attorney Conference Room (2nd Floor)
Thursday, April 6, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – First filing of Campaign Finance Report (Form C/OH)
Monday, April 24, 2023	<ul style="list-style-type: none"> • First day of early voting by personal appearance
Tuesday, April 25, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – Last day to accept application for a ballot to be voted by mail • <u>5:00 p.m. deadline</u> – Last day to accept an FPCA from a registered voter or from an unregistered FPCA voter
Friday, April 28, 2023	<ul style="list-style-type: none"> • <u>5:00 p.m. deadline</u> – Second filing of Campaign Finance Report (Form C/OH)
Tuesday, May 2, 2023	<ul style="list-style-type: none"> • Last day of early voting by personal appearance
Saturday, May 6, 2023	<ul style="list-style-type: none"> • ELECTION DAY (Polls open from 7:00 a.m. to 7:00 p.m.) • <u>7:00 p.m. deadline</u> – Last day to receive mailed ballots with no postmark, except overseas and armed forces ballots • Unofficial Tabulation of Results
Tuesday, May 9, to Wednesday, May 17, 2023	<ul style="list-style-type: none"> • Period for Official Canvass • Issue Certificates of Election, Official Statement of Elected Officer, Oath of Office
Monday, July 17, 2023	<ul style="list-style-type: none"> • Last day for timely filing of semiannual report of contributions and expenditures
